Agriculture and related activities, such as manure spreading, harvesting, open burning, biomass burning, machinery running on fossil fuels, fertilizer applications, soil fumigation, dairy farms, broiler and layer farms, green waste composting, cattle feed yards, and livestock wastes, emit large quantities of contaminants into the atmosphere. Historically, air quality associated with agricultural activities has been largely unregulated. Recently, however, state and local agencies have begun introducing regulations to minimize the impact of emissions from certain agriculturerelated activities on nearby residents and businesses.
